\*At the time of the publication of this premium list, there is no mask mandate in place for the State of Ohio. 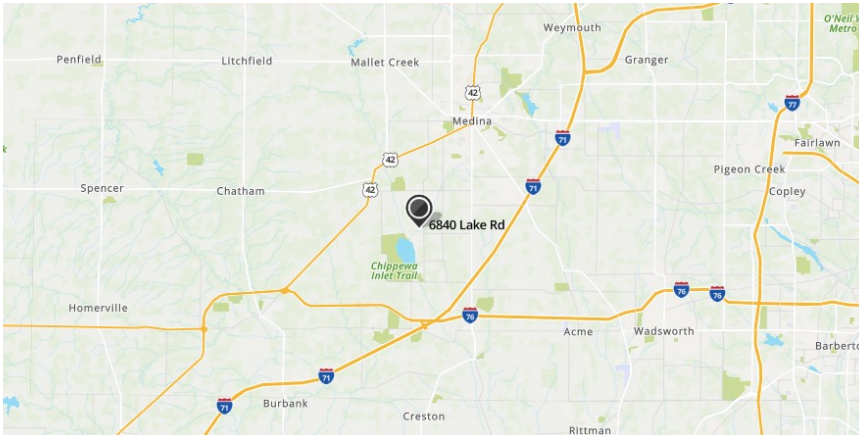
