Directions to Show Site

From Columbus, Cleveland and points NE: Exit off Interstate 70 at St. Rt. 42 (Exit 79). Go Southwest on St. Rt. 42 into London. St. Rt. 42 deadends into St. Rt. 38 (Elm St). Turn right (at the light) onto St. Rt. 38 (Elm St). Proceed North to the Fairgrounds, which will be on your left.

From Dayton/Springfield: Exit off Interstate 70 at St. Rt. 56. Go South towards London. Turn left on CR 136. Go to Elm Street and turn right. The Della Selsor building will be on your right, behind the County Extension Services.

From Cincinnati: Exit off Interstate 71 at St. Rt. 38. Go North towards London. Turn right onto St. Rt. 42. Turn left onto St. Rt. 56 at the London Courthouse. Follow St. Rt. 56 to Garfield Ave. The main entrance to the fairgrounds is on the right.
